

1 **RESOLUTION 04-02**

2 **A RESOLUTION OF THE CITY COUNCIL OF**
3 **THE CITY OF SAN GABRIEL**

4 **ADOPTING THE STREET TREE MASTER PLAN**

6 **WHEREAS**, the City’s General Plan encourages greening strategies within the
7 City’s residential and commercial neighborhoods; and

8 **WHEREAS**, the City contracted with the City Landscape Architect to develop a
9 program for street tree planting within the City; and

10 **WHEREAS**, the Community Development Department found the Street Tree
11 Master Plan categorically exempt per CEQA Guidelines Section 15301, Class 4: Minor
12 Alterations in the Condition of Land; and

13 **WHEREAS**, the Design Review Commission held a duly noticed public hearing
14 on September 22, 2003, after which time it made a recommendation for the City Council
15 to adopt this ordinance; and

16 **WHEREAS**, the Planning Commission held a duly noticed public hearing on
17 August 11, 2003, after which time it continued the hearing to November 12, 2003 and
18 made a recommendation for the City Council to adopt the program; and

19 **WHEREAS**, the City Council held a duly noticed public hearing on January 20,
20 2004 at which time it considered all evidence presented by the Community Development
21 Department and other interested parties both written and oral.

22 **NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SAN**
23 **GABRIEL DOES HEREBY RESOLVE AS FOLLOWS:**

24 **SECTION 1.** The City Council determines the Street Tree Master Plan is
25 compatible, consistent, and integrated with the Open Space Element, Land Use Element,
26 and all other elements of the City’s General Plan.


27 **SECTION 2.** That based on the recommendation of the Design Review


